Bat World Sanctuary is dedicated to the care, rehabilitation and release of injured bats as well as a sanctuary for non-releasable bats. This year 532 bats were rescued, and 502 of these were released back into the wild. We provided aid for bat rescues in Germany, Ireland, the Netherlands, Indonesia, Canada, Vietnam, Romania, Brazil, Bolivia, Australia, and Taiwan. As the only accredited sanctuary for bats in the world, we continue to collaborate with US Fish and Wildlife Department on efforts to control White Nose Syndrome. We continued to offer education programs for Animal Services officers, structural pest control operators and the USDA. Bat World Sanctuary engages in raising the awareness of the public through speaking engagements, publications and promotional items showing bats in a positive context, and online communication about bats through our website and social media pages. This year we reached over 2.5 million people online with information about bats. We presented live educational programs to Girl Scouts of America, schools and nature groups.
